Special instructions for completing application for counter guarantee

- General** The request for guarantee should be sent to EKN at the latest one month after issuing the contract guarantee.
- Item 2** If the contract guarantee conditions have changed (for example the beneficiary, amount etc.) so that they are no longer in accordance with what is laid down in the guarantee offer, this may mean that the offer is no longer binding on EKN. If such changes are being considered, the specific approval of EKN should be sought.
- Item 3:** The person on whose behalf the guarantor issues the contract guarantee. It could, for example, be a domestic subcontractor who has a transaction with a Swedish export company and where the final product is sold abroad.
- Item 6** The premium is paid in full in connection with the issue of the guarantee. Alternatively, it can be paid during the term of the counter guarantee, usually quarterly in advance. EKN charges a minimum premium of SEK 1,500 per commitment or period.
- Item 7** The applicant has in connection with the application for a counter guarantee provided information regarding debarment, notice served of suspicion of a crime, under charge or judgement. The applicant may here state whether any change has taken place in the said aspect compared to what was stated in the application.
